C: Organization (Large) Host a screening at your church or larger organization: *For people wishing to hold a screening with an audience of 75-150 the fee is \$250.00 Should you charge a ticket price it may not be less than \$5.00 per ticket and Intention Media will split revenues 50/50 beyond your initial \$250.00 fee(*). We will post your event on our website. (Optional). Receive 200 postcards and 25 posters to promote your event. We will also provide you with an approved email blast layout for your use. Receive a free copy of the film when it is released on DVD. You may hold 1 screening. You may pay an additional \$75.00 for each additional screening up to 3 screenings.*

() – Explanation of Split Revenue: Once you have calculated your final ticket sales, deduct your initial payment and then divide the remaining revenues by 2. You will keep \$275.00 and send Intention Media a check for \$275.00*
